# **European Campaign To Ban Glyphosate**

# Parkinson's Europe calls on the European Commission to STOP the 10-year licence renewal for controversial pesticide glyphosate

**THURSDAY 2nd NOVEMBER 2023 – Brussels:** Today Parkinson's Europe, the leading voice for people with Parkinson's in Europe, is urging EU Member States to **vote against the European Commission's proposed 10-year renewal of the licence to use the pesticide glyphosate in Europe** at the ScoPaff meeting taking place on **16th November**<sup>1</sup>.

This is due to growing concerns that exposure to glyphosate poses **public health risks**, including Parkinson's, other neurodegenerative disorders, and cancer.

While the EU's scientific body, the EFSA (European Food Safety Authority), concluded that the use of glyphosate "did not identify critical areas of concern"<sup>2</sup>, its recent report listed several **outstanding data gaps**, and many experts, including neurologist Prof. Bas Bloem<sup>3</sup>, believe the current EU testing and authorisation of glyphosate is flawed. Most notably, the current policy fails to understand the risk of neurodegenerative diseases, including **evidence that glyphosate is a possible cause of Parkinson's.** 

We therefore propose a **one-year extension** to glyphosate's licence which will allow time to undertake the necessary independent scientific research to fully demonstrate whether or not glyphosate is safe to use.

Russell Patten, Director General of Parkinson's Europe, said:

"The health risks posed by glyphosate don't just affect the Parkinson's community – but all of us in Europe. Protecting our health must be a top priority for EU policymakers so we urge them to do the right thing and vote against the glyphosate licence extension."

### **About Parkinson's**

- Parkinson's is the fastest growing neurological condition in the world, with over 10 million diagnoses globally – a number that is expected to double over the next 50 years.
- Parkinson's occurs when brain cells that make dopamine, a chemical that coordinates movement, stop working or die. The most common symptoms are tremor (shaking), slowness of movement and rigidity (muscle stiffness, but the condition can cause a wide range of other symptoms including anxiety, pain, sleep disturbance, mood and cognition issues and a decreased quality of life.
- There is currently no cure for Parkinson's. Symptoms are currently managed with medication, surgical treatments and complementary therapies.
