

PARKINSON'S EUROPE Giveaway Terms & Conditions

- For the purposes of these Terms and Conditions, "The Promoter" refers to Parkinson's Europe ("Parkinson's Europe"), a charitable organisation registered in Bruxelles (Numéro de l'association: 8727/2000, No TVA ou no entreprise: 465299201) and also registered in England and Wales (Charity Number 1163211).
- The "Prize" refers to one (1) copy of the 'The Parkinson's Plan: A New Path to Prevention and Treatment' book by Ray Dorsey and Michael S. Okun, published in English.
- By entering the competition you agree to be bound by these terms and conditions. All entries must be received by midnight on 11 October 2025. Three (3) winners in Europe will be selected at random by The Promoter on 12 October 2025, and the winners will be notified on or after this date.
- The Promoter's competitions are open only to residents of Europe. Three (3) winners will be chosen at random from all entrants and across all platforms. No purchase necessary. Winners will not be required to pay to enter the competition.
- Entrants must be over 18 years old on the date of their entry.
- Employees of The Promoter are not eligible to enter.
- Instagram or Facebook are not in any way affiliated or involved in the competition.
- Only one entry per person per competition will be accepted.
- Each entrant shall enter the competition by emailing info@parkinsonseurope.org, using the subject 'The Parkinson's Plan giveaway', and sharing their name and postal address.
- The Prize will be awarded to 3 randomly selected winners who have entered via email, using a [random number generator](#). The Promoter will not be held liable if the named prize becomes unavailable or cannot be fulfilled.
- The Promoter will not be held liable for any failure of receipt of entries. The Promoter takes no responsibility for any entries which are lost, delayed, illegible, corrupted, damaged, incomplete or otherwise invalid.
- To the extent permitted by applicable law, The Promoter's liability under or in connection with the giveaway or these terms and conditions shall be limited to the cost price of the Prize in question.
- To the extent permitted by applicable law, The Promoter shall not be liable under or in connection with these terms and conditions, the giveaway or any Prize for any indirect, special or consequential cost, expense, loss or damage suffered by a participant even if such cost, expense, loss or damage was reasonably foreseeable or might reasonably have been contemplated by the participant and the promoter and whether arising from breach of contract, tort, negligence, breach of statutory duty or otherwise.
